6.1 Vice-Chair Election

- L. Clarke explained the situation regarding eContent that libraries are facing. The five big multinational publishers have instituted punitive policies and embargos that are creating barriers to access.
- The Canadian Urban Libraries Council (CULC) is working together to put pressure on the publishers to make access to eContent more readily available at more reasonable costs. WPL is joining other libraries to amplify the issues
- L. Clarke has sent letters to the local federal candidates asking them to indicate their support in this matter

# 12.2 East Side Branch Library

- East Side Branch Library request for release of funding goes to City Council on Monday,
  December 9 2019. At that time the final design will be presented to Council
- ESBL Project Team including WPL, the City and John MacDonald and ward 99 Architects continue to meet biweekly, focusing on design. The project has undergone a value engineering process and has a confirmed budget
- Construction tenders to be posted in early 2020. Construction is anticipated to commence in March 2020 with occupancy Spring 2021 and an anticipated Summer 2021 opening

- O Summer Reading Club had 3,702 participants (including teens), an increase of 35% over 2018
- o End of the program party at McCormick drew 350 participants
